

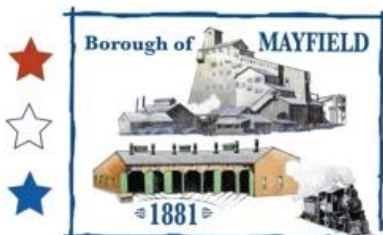

#### **Meeting to Close the Books on 2025**
